

MINUTES OF DIMONDALE PLANNING COMMISSION
PUBLIC HEARING AND REGULAR MEETING

7:00 p.m. Secretary Roesner called the Public Hearing to order and explained the purpose was to take comments on the Special Use Permit request from Dimes Brewhouse to allow live entertainment on the rear patio, "such entertainment could consist of an instrumentalist and vocalist either with or without a small amplifier" provided that not more than a total of 20 watts of amplification is used. Outdoor music must cease at 10:00 p.m.

Prisk explained that each person will be limited to one, five-minute comment period.

1. Motion by Stiles, second Reiffer, to approve the minutes of the February 27, 2023 regular meeting. Motion carried.
2. Roesner introduced the Special Use Permit (SUP) request from Dimes Brewhouse for music on the rear patio. Prisk presented the findings of fact from the April 2018 SUP regarding parking which concluded a lack of parking issues. Prisk encouraged the Commission to follow the standards established in Chapter 1293.03 during determination. Motion by Stiles, second Whitford, to approve the Special Use Permit as presented. Discussion followed regarding lack of parking problems and impact on adjoining residential uses. Roesner reviewed and received consensus from the Commissioners on each of the approval standards for a Special Use Permit. Roll Call Vote: Yes: Reiffer, Roesner, Stiles, Whitford; No: none; Absent: Macak. Motion carried.

5. Roesner presented the Annual Report for member review. Motion by Stiles, second Reiffer, to approve the report. Motion carried.
