# Recommendations/Reports from Council Committees and Village Officers

- 1. Reznick reported on passage of the Holt Schools bond proposal and trees on Windsor Hwy.
- 2. Gallagher submitted a written report and added that funds have been appropriated for the park grant. Conarton noted that Parisian did not have internet service and would provide a report at the Recreation Task Force meeting. Ammarman noted that Hayhoe Asphalt has generously donated time and materials to crack seal the basketball court.
- 3. Conarton reported on the May 3, 2021 Communications Committee meeting.
- 4. Ammarman reported on the May 5, 2021 Public Works Committee noting that two recommendations were generated and appear under new business.

# **Unfinished Business**

1. Conarton presented a revised proposal for flower baskets and banners on the downtown light poles demonstrating that the baskets will not affect the flags or holiday wreaths and can stay up year-round. Discussion followed regarding whether the liners stay in, effect on light disbursement and DPW labor for watering. Motion by Campbell, second Ammarman, approve up to \$1,000 for flowers for the baskets and to begin design on six banners. 2 Reznick presented a recommendation from the Public Works Committee to apply for the 50/50 Category B grant construction match for Pine St. from Washington St. to Quincy St., the full length of Quincy St., Birch Ln. and Cherry St. Campbell requested a voting abstention based upon his employment with the State of Michigan. Motion by Conarton, second Toomey, to apply for the grant as presented. Roll call vote: Yes: Ammarman, Conarton, Reznick, Tardino, Toomey; No: none; Abstained: Campbell; Absent: Bower.
