Trustee Conarton led the Pledge of Allegiance.

**Approval of Agenda**

Tiedeman requested an agenda amendment under New Business for the Hoehn Court reconstruction project. Motion by Campbell, second Haidamous, to approve the April 14, 2025 agenda as amended. Motion carried.

**Minutes**

Motion by Conarton, second Campbell, to approve the March 10, 2025 Regular Meeting minutes. Motion carried.

**Treasurer's Report**

The March 31, 2025 treasurer's report was filed with no corrections.

**Bills**

The bills were reviewed. Motion by Campbell, second Haidamous, to approve payment of \$54,902.28 in the General Fund, \$2,053.04 in the Major Street Fund and \$1,033.97 in the Local Street Fund for March 31, 2025 bills and transfers. Motion carried.

Sgt. Popa, ECSD, provided a report for March 2025.

Allen Matthews, village resident, spoke regarding the Consumers Energy project on Creyts Rd and the potential negative impact on mature trees.

**Unfinished Business**

1. No unfinished business was presented.

**New Business**

1. Haidamous presented the Planning Commission Annual Report for member review.
2. Reznick stated that two appointments need to be made to the Planning Commission by June 2025 noting that there are three interested individuals, Garry Macak (reappointment); Tabitha Weekes-Boyles and Greg Porter for new appointment. Both Weekes-Boyles and Porter addressed the Council as well as answered questions regarding education, experience and community involvement. After consideration, Reznick suggested retaining Macak and making one new appointment. Motion by Conarton, second Haidamous, to reappoint Garry Macak to the Planning Commission for a term to expire in June 2028. Motion carried. Reznick then called for a show of hands for Weekes-Boyles and Porter with the table divided three to three. Discussion followed regarding tabling the issue until all seven Council members were present to eliminate the tie. Greg Porter suggested appointing Weekes-Boyles noting that he could be involved at a different level. Motion by Tardino, second O'Neal, to appoint Tabitha Weekes-Boyles to the Planning Commission for a term to expire in June 2028. Motion carried.
3. Tiedeman requested a change to the ACH Policy allowing managerial approval for adding vendors and subsequent reporting the Village Council for transparency. Motion by Campbell, second Tardino, to approve the request as presented. Motion carried.

4. Tiedeman presented the MI CLASS Investment Resolution. Motion by Campbell, second Haidamous, to approve the resolution as presented. Motion carried. (Copy attached.)

5. Haidamous presented a contract increase for the Hoehn Court repaving project from \$83,000.00 to \$95,783.00. Campbell spoke about the high percentage of the increase on top of the previous 5% increase and being fiscally responsible with Village dollars. Discussion followed regarding passer ratings and rebidding. Motion by Campbell, second O'Neal, to table the issue until next month. Motion carried.
