#### **Bills**

The bills were reviewed. Motion by Bower, second Campbell, to approve payment of \$85,799.84 in the General Fund; \$3,112.79 in the Major Street Fund; \$4,793.30 in the Local Street Fund; and \$1,077.25 in the Farmers' Market Fund for November 14, 2022 bills and transfers. Motion carried.

## Recommendations/Reports from Council Committees and Village Officers

- 1. Reznick reported on the elections results and congratulated Ammarman on his seventeen years of service. le also thanked Campbell for his service and offered congratulations to Toomey on his new County Commissioner seat. Reznick also thanked Gallagher for his time spent at the Village.
- 2. Gallagher reported on the following: completion of draft budget, office transition, DNR grant extension, and communications to all contractors and consultants about the change in management.
- 3. Conarton reported on the October 12, 2022 Management Committee meeting.
- 4. Tardino reported on the October 19, 2022 Recreation Committee meeting.
- 5. Bower reported on the October 27, 2022 Administration Committee meeting.
- 6. Reznick reported on the November 7, 2022 Council Work Session

#### **New Business**

- 1. Reznick introduced a recommendation from the Recreation Committee to host the holiday light pole decorating contest. Motion by Bower, second Campbell, to support the recommendation. Motion carried.
- 2. Reznick presented language for the plaque commemorating "A River Runs Through Us". Motion by Campbell, second Toomey, to approve the language. Motion carried.
- 3. Reznick presented the request for MML membership and support of the legal defense fund. Motion by Toomey, second Tardino, to renew the membership without the legal defense fund. Motion carried.
- 4. Reznick introduced the continuing services agreement for Gallagher in case he needs to return to provide assistance to the organization during the transition and suggested that the same rate (\$40/hour) apply to Parisian if she is needed. Reznick also proposed that Kelly function as acting manager if the new manager is unable to take over before Gallagher leaves. Motion by Campbell, second Ammarman, to accept the continuing services agreement for Gallagher. Motion carried. Motion by Campbell, second Bower, approve paying Denise Parisian the same as Gallagher on an as needed basis. Motion carried. Motion by Campbell, second Tardino, to appoint Kelly as acting Manager as discussed with a possible bonus yet to be determined. Jotion carried.
- 5. Tardino provided information on the proposed Ram Trail extension to Dimondale noting that this amenity to the residents will connect the Dimondale Elementary with a four mile paved trail to the Holt High School. She explained that the task force is looking for support from the Village Council for the conceptual design and to

appoint an official to represent the Village at future meetings. Motion by Toomey, second Bower, to appoint Tardino as the Council representative and endorse the feasibility study in concept. Motion carried.
